A Note from the President

Hi Neighbors,

I hope you've noticed the new fences going up around our neighborhood. Eight years ago, I signed up on the HOA fence committee and also as a board member at large. I'm done. Bye. Ok, just kidding. We have a great start on improving the looks of our neighborhood and still have more we can accomplish. Through this year's cost share program, our



neighbors along Bryant replaced 466 feet of fence and 495 feet along Covell. That is only 961 of our 2,398 feet of perimeter fence.

Our brick mason, Charlie Keyser, also leveled 14 brick columns and re-mortared 26 of the grey top caps on the columns. The mortar had failed through the years and the caps were dangerously loose. Charlie has done nice work for us for many years and can be reached at (405) 834-2420. The fence vendor, Cedar Forest Fence Co., also did good work and their number is (405) 219-4250. The new fence is no longer attached to the brick columns. The columns have no footing and are not designed to support attached fencing. If you choose to replace your own fence, please place metal posts on each side of the columns to support the fence and absorb the force of the Oklahoma winds.





For some neighbors it was bad timing financially. We understand and the HOA still has some capital funds available to repeat the program next spring. We need commitments from fence owners now so we can budget accordingly. If you appreciate improvements to the neighborhood, please pay your dues.
